ORDER:

The Chairman, Shree Venkateshwara Educational and Charitable Trust, Erode District has requested the Government to grant permission to start four years Bachelor of Occupational Therapy (BOT) Course in the name and style as "Shree Venkateshwara College of Paramedical Sciences", Othakuthirai, K.Mettupalayam (Post), Gobichettipalayam, Erode District with an annual intake of 100 seats from the academic year 2020-2021.

2. In Government letter third read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Occupational College has fulfilled the conditions prescribed by the Government in the Government Orders first and second read above.

In his letter fourth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Chairman, Shree Venkateshwara Educational and Charitable Trust, Erode District to start four years Bachelor of Occupational Therapy (BOT) Course in the name and style as "Shree Venkateshwara College of Paramedical Sciences", Othakuthirai, K.Mettupalayam (Post), Gobichettipalayam, Erode District with an annual intake of 100 seats from the academic year 2020-2021.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Chairman, Shree Venkateshwara Educational and Charitable Trust, Erode District to start four years Bachelor of Occupational Therapy (BOT) Course with an annual intake of 100 (hundred) seats in the name and style as "Shree Venkateshwara College of Paramedical Sciences", in R.S. Nos.1354, 1356/4A, 1356/8 at Sri Kalaivani Nagar, Othakuthirai, Kugaloor (B) Village, Gobi Taluk, Erode District - 638 455 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.152, Health and Family Welfare (PME) Department, dated: 25.04.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the DTCP for Shree Venkateshwara College of Paramedical Sciences.
 - ii. The Trust should obtain building completion certificate from competent authority i.e. PWD.
 - iii. The Trust should obtain affiliation from the Tamil Nadu Dr. M.G.R. Medical University, Chennai.
5. The Director of Medical Education is directed to take necessary further action accordingly.
