PREAMBLE:-

In the reference 1st cited, the Government in G.O(Ms) No.487, Health and Family Welfare (PME-2) Department, Chennai has permitted the Chairman, Shree Venkateshwara Educational & Charitable Trust, Gobichettipalayam, Erode District to start four years Bachelor of Occupational Therapy (BOT) course with an annual intake of Hundred (100) seats in the name and style as SHREE VENKATESHWARA COLLEGE OF PARAMEDICAL SCIENCES, Othakuthirai, K.Mettupalayam (Post), Gobichettipalayam, Erode District – 638 455 for the academic year 2020-2021.

2. In the reference 2nd cited, the Chairman, Shree Ve**nk**ateshwara Educational & Charitable Trust, Gobichettipalayam, Erode District has **re**quested the University to issue Permission to start the BOT Degree Course at **SHREE VENKATESHWARA COLLEGE OF PARAMEDICAL SCIENCES**, Othakuthirai, **K**.Mettupalayam (Post), Gobichettipalayam, Erode District – 638 455 with an an**n**ual intake of Hundred (100) seats for the academic year 2020-21

- 3. An Inspection was conducted on 23.12.2020 by the Inspection commission constituted for the said purpose and the commission has submitted its report. Scrutiny of the inspection report indicates the institution has fulfilled the necessary requirements for the issue of Certificate of Registration and the grant of Order of Provisional Affiliation for the starting of the BOT Degree course with an annual intake of Hundred (100) seats.
- 4. There is no separate Central Council for Occupational Therapy. Therefore, there is no impediment to the issue of Certificate of Registration and grant Order of Provisional Affiliation together.
- 5. In the reference 4th cited, the University has granted "Certificate of Charitable Educational & to Shree Venkateshwara Gobichettipalayam, Erode District for the establishment of a new institution in the name and style of SHREE VENKATESHWARA COLLEGE OF PARAMEDICAL K.Mettupalayam (Post), Gobichettipalayam, Othakuthirai, to start the BOT Degree Course with an annual intake of SCIENCES, District - 638 455 Hundred (100) seats for the academic year 2020-21.

ORDER:-

Consequent to the issue of the Certificate of Registration, the University grants the order of Provisional Affiliation to SHREE VENKATESHWARA COLLEGE OF Othakuthirai, SCIENCES,(BOT) Gobichettipalayam, Erode District – 638 455 to start the BOT Degree Course with an annual intake of Hundred(100) seats for the academic year 2020-21.

- a) This order is granted subject to usual terms and conditions which are given in the Annexure.
- b)Any other condition, which the University considers necessary to impose from time to time, should be followed.

Pursuant to the grant of Order of Provisional Affiliation, the Code Number alloted to SHREE VENKATESHWARA COLLEGE OF PARAMEDICAL SCIENCES, K.Mettupalayam (Post), Gobichettipalayam, Othakuthirai, 455 is 883.

ANNEXURE

The Provisional Affiliation is granted subject to the following specific conditions along with other general conditions:-

- The Trust should obtain building plan approval from the DTCP for Shree Venkateshwara College of Paramedical Sciences.
- The Trust should obtain building completion certificate from competent authority i.e. PWD.

- iii. The admission procedure and other conditions prescribed by the Government of Tamil Nadu shall be followed strictly. The institution shall fill up the seats as per the orders in force.
- iv. The candidates should be admitted before the cut off date and they will be registered to take up their Ist year BOT examination as per the existing regulations of this University.
- v. The College should undertake to abide by the Provisions of the Tamil Nadu Dr.M.G.R. Medical University, Chennai Act, 1987 (Tamil Nadu Act 37 of 1987) and by the Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University applicable to the Occupational Therapy Colleges framed from time to time.
- vi. The Occupational Therapy College should agree for the inspection of the college by the Tamil Nadu Dr.M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Occupational Therapy Colleges framed from to time.
- vii. The Occupational Therapy College should abide by the Statutes, Ordinances, Regulations and rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, extracurricular activities etc.,according to the Statutes, Ordinances Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University framed from time to time.
- viii. Only qualified staff shall be appointed to handle the classes in the B.O.T. Degree Course.
- ix. Only eligible candidates according to the regulations of this University shall be admitted to the Ist BOT Degree Course. While making admissions, the Rule of Reservations of the Government of Tamil Nadu shall be adopted strictly.
- x. The maximum number of students that shall be admitted the Ist BOT Degree Course shall not exceed the sanctioned strength .
- xi. There shall not be any financial commitment either to this University or to the Government.
- xii. Hostel accommodation shall be made available for the students both Male and Female.
- xiii. Required furniture shall be provided wherever they are necessary.

xiv. Furnishing of false information to the University on any matter of suppression of facts while furnishing information to the University or violation of any of the Statutes, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the affiliation of the college.

xv. The institution shall furnish an evidence of an annual income of not less than Rs.10,00,000/-(Rupees ten lakh only) excluding the interest accrued from the Security Deposit mentioned in these statutes to facilitate the proper running of the Occupational Therapy College.

xvi. The institution shall furnish all the teaching and other staff details with qualifications, experience, date of joining etc., whenever required by the University.

xvii. The College shall furnish a "Utilization Certificate" to the University stating that the interest accrued on the Security Deposit created with this University shall be utilized towards maintenance of the Occupational Therapy College.

xviii. The College shall have a duly constituted Governing Body with representatives of the teaching staff, to advise the Principal in the internal affairs of the college. A record proceedings of the said Governing Body of the college shall be maintained by the Principal.

xix. The Governing Body of the College shall meet at least once in three months to consider the budget estimates and such other matters as may arise in its working. It shall meet May-June each year to consider the Annual Report, the audited statement of accounts, changes in the staff, subjects or courses in which fresh provisional Affiliation or approval is to be sought in the following year.

xx. The college shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the second, third and fourth year of the course of study.

xxi. The Provisional Affiliation now granted by the University is for the first year of B.O.T. degree course only.

xxii. After fulfilling all the conditions required to be fulfilled by the College under the Tamil Nadu Dr.M.G.R. Medical University (Affiliation of Occupational Therapy Colleges) Statutes, by the time only six months period is left for the first year B.O.T. Degree Course of study, the institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year B.O.T. Degree Course of study.

xxiii. During the University Examinations, the question papers will be sent through Internet for which the following equipments have to be purchased and kept ready by the institution.
